Vice Mayor Holley reported on the success of the Octoberfest. Over \$20,000 was raised and approximately 6,000 people attended.

Linda Webb reported on the success of a new program "Walk with Ease" to help those with arthritis. This program may be repeated in the spring of 2018.

Linda Webb reported on the upcoming Christmas parade to be held on Saturday, November 25. The lineup will begin at 10:00 AM at Louisville Chriatain Church on Topside Road. The parade will begin at 11:00 AM and proceed down Louisville Road to Town Hall. Rainout date is the next day on Sunday, November 26 at 2:00 PM.

Town Engineer Swicegood reported on a meeting with aTDECrepresentative at the Brewster property on Samples Road. Storm water runoff and erosion on this property has been creating a big problem on Samples Road. TDEC has notified the property owner that they are in violation of TDEC regulations and must take corrective action.

Town Engineer Swicegood updated the BMA on discussions with the engineer and developer for Osprey Point subdivision on Old Lowes Ferry Road. Mayor Bickers and Tom Swicegood met with these folks on Wednesday, October 04 to make them aware that a Subdivision Regulation variance must be obtained from the Planning Commission if they chose to not install fire hydrants aas part of their development.
