Mayor Bickers called the meeting to order at 6:00 p.m.

Mayor Bickers led the Opening Prayer and the Pledge of Allegiance to the flag.

MOTION by Gormley to approve the minutes of the November 14, 2017 meeting of the BMA. Second by Smith. **VOTE: UNANIMOUS. MOTION PASSES.**

Mayor's Report and Approval of Monthly Financial Report:

Financial report for month ending December 31 was reviewed.

MOTION by Gormley to accept the December monthly financial report. Second by Pugh. **VOTE: UNANIMOUS. MOTION PASSES.**

Mayor Bickers reported that the agreement with the BCSO is finalized and undergoing implementation. The TOL now has two dedicated full time officers. Rex Ogle is on board Monday through Friday. The second officer has not been named but Mr. Ogle is currently supplemented by other BCSO personnel. Radar in school zones has been an emphasis.

Mayor Bickers reported on another successful MEDIC blood drive last week. There were 32 donors which is a good turnout in spite of the very cold weather.

Citizens Comments: David Christopher commented on gun discharge by a neighbor on Rankin Ferry Loop and the need for some type of regulation in the TOL. Bruce Icenhower asked about collection of funds for demolition of a home by TOL and several other topics. Ron Kudich commented about his concerns for codes enforcement needed at several properties in the TOL.

Resolutions and Ordinances: None

Other Action/Discussion Items:

1. Regulations for discharge of firearms: Mayor Bickers described the background concerning this issue. Alderman Gormley commented on the need for a public hearing since growth inside the TOL has changed this issue. Officer Ogle noted that currently complaints can be made at dispatch 983-3620 to have an officer investigate. Mayor Bickers will schedule a public hearing on this issue for the February 13 BMA meeting as part of the agenda

2. Purchase of standard fleet truck for maintenance: Mayor Bickers presented for discussion the need for a standard fleet truck for the maintenance department. Without objection, the Mayor will get a request for bids prepared to purchase a standard, gas powered truck for mundane tasks. A Ford F150 or equal will be specified and three bids will be required since the total cost will exceed \$10,000. All BMA members were in agreement to move forward.
