Mayor Bickers called the meeting to order at 6:00 p.m.

Mayor Bickers led the Opening Prayer and the Pledge of Allegiance to the flag.

MOTION by Pugh to approve the minutes of the May 08, 2018 meeting of the BMA. Second by Smith. VOTE: UNANIMOUS. **MOTION PASSES.**

Mayor's Report and Approval of Monthly Financial Report:

Financial report for month ending May 31 was reviewed.

As of 05/31/2018 \$2, 124,749.65

MOTION by Smith to accept the May monthly financial report. Second by Pugh. VOTE: UNANIMOUS. **MOTION PASSES.**

Mayor Bickers reviewed past discussions and suggestions concerning firearms discharge within the Town incorporated boundaries. Mayor Bickers presented information about gun discharge ordinances in other Blount County municipalities. Alcoa, Maryville and Townsend ban all recreational shooting. Friendsville bans recreational shooting on tracts less than five acres. Rockford has no ban and treats gun discharge within noise regulations. Mayor Bickers reviewed appropriate existing State law regarding hunting and firearm discharge. Mayor Bickers then reviewed the proposed Town of Louisville Ordinance with emphasis on revisions resulting from input and discussions.

Citizens Comments: Approximately ten citizens and four noncitizens commented on the proposed Ordinance, which would place some limits on firearm discharge within the Town of Louisville boundaries.

A RESOLUTION CALLING FOR THE ELECTION OF MAYOR AND TWO ALDERMEN

Proposed Road Improvements FYE 2019: Town Engineer Swicegood requested approval from the BMA to issue the specifications for bidders for the 2018-2019 Road Improvements which include paving Rankin Ferry Loop, Boatdock Road and Mentor Alley. Bids would be due July 06 and can be reviewed by the BMA at the July meeting

MOTION by Bickers to approve issuing the specifications for bids as proposed.
Second by Smith. VOTE: UNANIMOUS, **MOTION PASSES**
