- The applicant agrees to keep the street (private or public) or roadway free of dirt, mud, stone, gravel and etc.
- The existing drainage of ditches, swales and etc. must be maintained with the use of pipes, culverts and etc.
- All driveway entrances shall have a paved surface that extends 15' from the edge of the street's pavement or to the outer limit of the right-of-way, whichever is greater.
- Failure to comply to the above stipulations may result in the revocation of this permit and/or assessment of clean-up cost.
- Driveway permits on State of Tennessee roads (Topside Rd and Louisville Rd) must be obtained from the Tennessee Department of Transportation (865)594-2456.
- The roadway clean-up agreement applies to these state roads also.
- For any project that requires more than 200 cubic yards of off-site dirt to be hauled to the site, the applicant agrees that the dirt will be free of any hazardous material, toxins & etc.

In making this application states that the information given is correct and that the construction will conform to the regulations of the current adopted codes and ordinances of the Town of Louisville. The applicant acknowledges that the issuance of a permit does not presume to give authority to violate or cancel the provisions of any other state or local law regulation construction.
